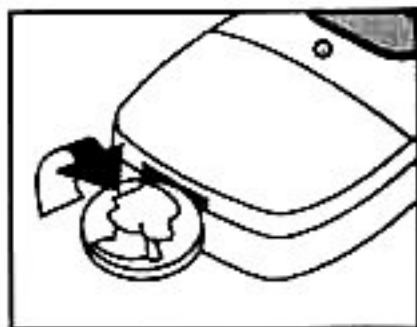


PROGRAMMING YOUR NEW TRANSMITTER

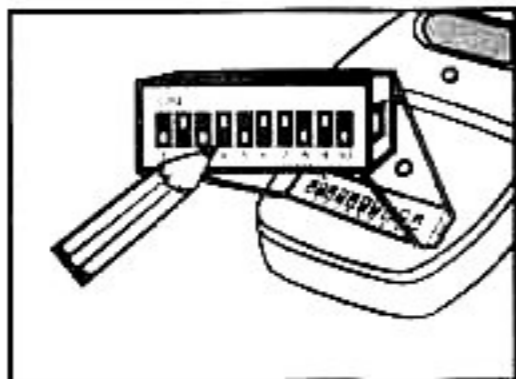
1. Open the case, as shown.



2. For code setting :
Open your existing transmitter, or the cover on receiver located on your operator and follow the steps corresponding to your brand of garage door opener. Then re-close the cover.

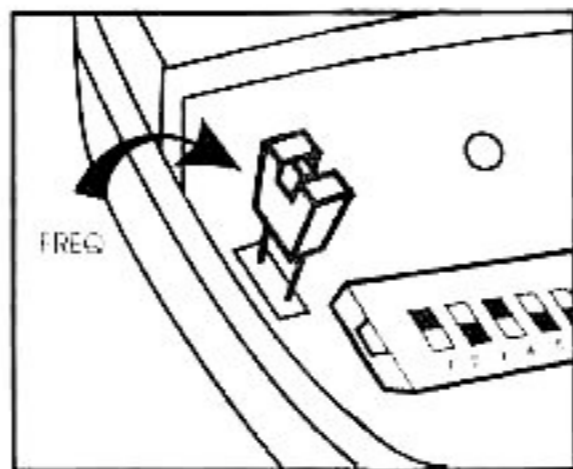
FOR MULTI-CODE® & STANLEY® OPERATORS (300MHZ)

1. Use a pen to set the DIP switches to match the code of your existing transmitter or receiver.
2. You do not need to relocate 'CODE' and 'FREQ' jumper for Stanley® and Multi-Code® (300 MHz) operators.



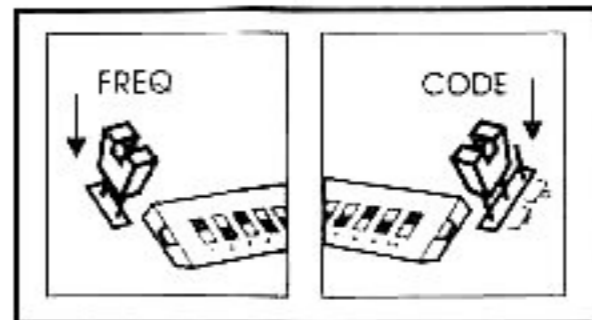
FOR MULTI-CODE® & STANLEY® OPERATORS (310MHZ)

For Stanley®, Multi-code® (310 MHz) operators. Insert the jumper to cover the 'FREQ' two pins but DO NOT relocate the 'CODE' jumper block.



FOR LINEAR®, or MOORE-O-MATIC® OPERATORS (310MHZ)

1. Use a pen to set the DIP switches to match the code of your existing transmitter or receiver. The last two switches are not used for Linear® and Moore-O-Matic® operators.
2. Insert the jumper to cover the 'FREQ' two pins and insert the 'CODE' jumper to the lower two pins.



BATTERY

12 volt "cigarette lighter" type (size 23A battery (included))



WARNING

If this transmitter triggers other garage doors in your neighbourhood, change all your transmitters and receiver to a new code setting.

DO NOT let children use the garage door transmitter without adult supervision. Children can injure themselves or others by the garage door.

WARRANTY

If, within one year from date of purchase, this product should become defective (except battery), due to faulty workmanship or materials, it will be repaired or replaced, without charge. Proof of purchase is required.

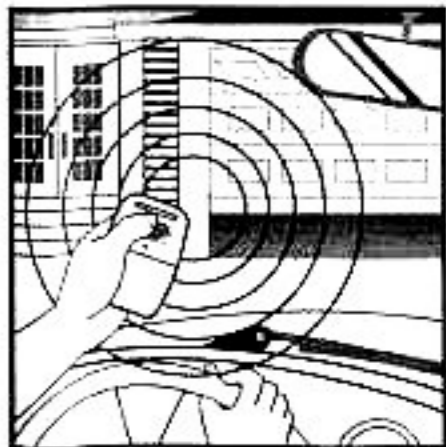
